The Board ratified the administrative and financial approval accorded by the Chairperson, BoG for organizing the IEEE the Power Electronics, Drives and Energy Systems (PEDES) 2022 conference at MNIT, Jaipur from 14 to 17 December 2022.

The Board was apprised about the grievances of Technicians regarding their promotion through DPC 2019. Institute advertised for the recruitment of Senior Technician/ Senior Work Assistant through Advertisement No. AES/MNIT/Estt/2021/01 without mentioning the vacancy positions. 26 candidates have been recruited in 2021 against the pool of 31 posts without obtaining appropriate approval from BoG.

Resolution No. BoG-51/2022/01: Considering the current challenge for regularization of newly appointed 26 candidates in 2021, Board discussed for regularization of 26 recruited candidates by transferring 26 Nos. of posts from technical higher cadre to technical lower cadre without having financial liability to MoE. Board agreed in principle for the proposal and directed to send the proposal to the MoE for the approval. After obtaining the approval from the MoE, Board agreed to conduct review DPC 2019 by incorporating the quota of direct recruitment of 21 posts of Senior Technician so that the grievances of Technicians may be addressed.

Item No. 51-5.2: To consider the grievance of Technical Assistants regarding their promotion through the DPC-2020.

Resolution No. BoG-51/2022/02: The proposal was presented before the Board and was discussed in detail. The Board approved the proposed resolution to conduct review DPC to address the grievance of Technical Assistants regarding their promotion through the DPC-2020. However, the Institute is to ensure that the matter is not sub judice or have any legal implications.

Item No. 51-5.5: To consider the proposal for appointment of adjunct faculties.

Resolution No. BoG-51/2022/06:

The process for the appointment of Adjunct Faculty was presented by Dean (FW) including the existing approved guidelines. After due deliberations, the Board agreed for the appointment of 25 Adjunct Faculty members and desired that before implementation, the proposal may be discussed with the Director IIT Delhi.

The Board directed to prepare a detailed proposal including rules, norms and guidelines to implement the scheme for appointment of the Professor of Practice based on IIT Delhi / IIT Madras/ IIT Roorkee models. The Board further directed that the total number of proposed Professors of Practice and Adjunct Faculties should be within the sanctioned strength.

Item No. 51-5.6: To consider the mercy plea for relaxing the penalty imposed by the Internal Complaints Committee (ICC) on two B. Tech students.

Resolution No. BoG-51/2022/07: The Board observed that the matters pertaining to the students need to be handled at the level of the Director through the existing channel of the Dean, Student Welfare. Director will be the Appellate Authority related to student affairs.
