Pre-bid Presentation

All interested OEMs are requested to send their technical representatives (maximum two persons from an OEM, carrying official ID) for Pre-Bid presentation before the committee on 18th Sep at 2.00 PM at Computer Centre, MNIT Jaipur, after which the committee may revise the tender document and the same will be uploaded on the websites of MNIT Jaipur and NIT Jalandhar. Any queries/representations of any supplier/OEM after that presentation will not be entertained by the committee/institute. Interested OEMs shall intimate in advance about their participation on datacentre@mnit.ac.in so that a time slot may be booked for them.

Two clauses of the present Tender Document are also being revised as under:

[A] Clause No 8

Previous Clause: Bidder should be either an Original Equipment Manufacturer (OEM) of IBM, Dell, Cisco, HP or EMC2 brand or its authorized distributor/reseller of IT products. If bidder is not OEM, then it should have full service support from OEM for the quoted equipment. The bidders shall submit the Certificate of Authorization in original issued by the OEM for participation in this bid failing which the bid will be rejected.

Revised Clause: Bidder should be either an Original Equipment Manufacturer (OEM) of **HP, Dell, Lenovo, Cisco (for Blade Server and Chassis) and EMC, Hitachi Data System, HP, Net App, IBM, Dell (for SAN Storage)** brand or its authorized distributor/reseller of IT products. If bidder is not OEM, then it should have full service support from OEM for the quoted equipment. The bidders shall submit the Certificate of Authorization in original issued by the OEM for participation in this bid failing which the bid will be rejected.

[B] Clause No 9

Previous Clause: The Indian/Foreign agents participating in the tender must have the average annual turnover not less than 15 crores for last three years with single order of similar equipment amounting more than 1 crore. As proofs for the same, balance sheet of last three years and copy of the order be provided.

Revised Clause: The Indian/Foreign agents participating in the tender must have the average annual turnover not less than **1.5 crores** for last three years with single order of similar equipment amounting more than 1 crore. As proofs for the same, balance sheet of last three years and copy of the order be provided.
