2. 2. It may be noted that benefit of EMD exemption and purchase preference to MSME will be given only to the manufacturers for the respective goods and service providers for respective services. Any trader including authorized dealer of OEM / service provider submitting MSME certificate will not be considered under MSME category for this bid and these benefits will not be applicable to such firm.

3. For EMD exemption, if firm doesn't claim under relevant category, his EMD exemption claim will not be considered and the bid will be rejected. *For example if a firm wants to claim EMD exemption on the basis of MSME Udyam Certificate, the firm has to claim EMD exemption under 'MSE Category' option on Gem Portal. 4. Past Project Experience:-

6. **Force Majeure**

If at any time, during the continuance of this contract, the performance in whole or in part by either party of any obligations under this contract shall be prevented or delayed by reason of any war, or hostility, acts of the public enemy, civil commotion, sabotage, fires, floods, explosions quarantine restrictions, strikes, lockouts or act of God (herein after referred to as events)

provided notice of happenings, of any such eventually is given by party either party to the other within 21 days from the date of occurrence thereof, neither party shall be reason of such event be entitled to terminate this contract nor shall either party have any such claim for damages against the other in respect of such non-performance, or relay in performance, and deliveries under the contract shall be resumed as soon as practicable after such event may come to an end or cease to exist, and the decision of the Director MNIT Jaipur will be final and conclusive.

7. **Arbitration**

- a. If a dispute of any kind whatsoever arises between the MNIT Jaipur and the bidder in connection with, or arising out of, the Contract or the execution of the works or after their completion and whether before or after the repudiation or other termination of the contract, including any disagreement by either party with any action, in action, opinion, instruction, determination, certificate or valuation of the Engineer, the matter in dispute shall be settled by arbitration in accordance with the Indian Arbitration and Conciliation Act, 1996 or any statutory amendment thereof.
- (b) The reference to arbitration may proceed notwithstanding that the works shall not then be or be alleged to be completed, provide always that the obligations of the MNIT Jaipur and the bidder shall not be altered by reason of the arbitration being conducted during the progress of the works. Neither party shall be entitled to suspend the works, payments to the bidders shall be continued to be made as provided by the contract.
- (c) Arbitration proceedings shall be held at Jaipur and the language of the arbitration proceedings and that of all documents and communications between the parties shall be English.
- (d) All arbitration awards shall be in writing and shall state the reasons for the award.
- (e) Penalty/Liquidate Damages shall not fall under the Arbitration clause.

8. **Cancellation / Postponement of Programme**

In case the organizing of the Event is cancelled or postponed due to any reason, no claims shall be made by the bidder on MNIT Jaipur.

- 9. In case of defective works the same shall be rectified by the contractor at his own cost.
- 10. The contractor will be responsible for transportation of all materials released to his/her work and no extra payment will be made by the institute on this account.
- 11. All material used should be very high quality, If the material used is not of good quality deduction will be made from the bill.
- 12. As the tournament is an important event of the Institute, timely completion of work and quality of material would be important. The committee in this regard may inspect material to be used for the work before awarding the work.
- 13. MNIT, Jaipur reserves the right to curtail or enhance the scope of work either by removing of certain items entirely or by reducing/increasing the quantities of certain items as required by the Institute from time to time and therefore, the final value of the work shall be worked out and paid to the extent of work actually carried out.
- 14. Subletting the awarded work to other party is not allowed. If found, appropriate action will be taken against successful bidder.
- 15. The prospective bidder must visit the site of the Event before the Bidding to physically verify, gauge and satisfy themselves the requirements of the instant tender, before uploading the bids.
- 16. The Prospective bidder must provide sample of item(s)/ goods before the commencement of the work to the organizing committee.

जेम की सामान्य शर्तों के खंड 26 के संदर्भ में भारत के साथ भूमि सीमा साझा करने वाले देश के बिडर से खरीद पर प्रतिबंध के संबंध में भारत के साथ भूमि सीमा साझा करने वाले देश का कोई भी बिडर इस निविदा में बिड देने के लिए तभी पात्र होगा जब वह बिड देने वाला सक्षम प्राधिकारी के पास पंजीकृत हो। बिड में भाग लेते समय बिडर को इसका अनुपालन करना होगा और कोई भी गलत घोषणा किए जाने व इसका अनुपालन न करने पर अनुबंध को तत्काल समाप्त करने और कानून के अनुसार आगे की कानूनी कार्यवाई का आधार होगा।/In terms

of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
